# **SCM Redevelopment Update** – P. Chatelain

- Meetings were held with the Town of Iroquois and Minister of Long Term Care on August 19. We have received the development agreement. The goal is to begin construction in November, and the drawings are now considered approved.
- The pre-qualification tender process has started and will last for 3 weeks. The first tender is expected to be issued by the first week of September.
- Project construction scheduled for November 2024.
- Prices are expected to be within expectations and interest rates are trending downward. The project will be exempt of GST & HST.
